Kids Universe Pre-purchase Ticketing Promotion

Terms & Conditions

1. The promotion will run nationally from July 14, 2004 to midnight September 26th, 2004.
2. It will be known as the "Kids Universe Pre-purchase Ticketing Promotion".
3. Employees, and their immediate families, of Kids Fest Sydney and its associated agencies, and companies associated with this promotion, including Ticketmaster 7 & Qantas, are not eligible to enter.
4. One major prize and four additional prizes only will be offered via this promotion,
5. The Major prize valued at \$9,400. The prize pack consists of
 - 2 adult return economy class air fares from Sydney to Los Angeles – Value \$3600
 - 2 children's (age 12 and under) return economy class air fares from Sydney to Los Angeles – Value \$2800
 - Accommodation for a family of four for 2 nights convenient to Disneyland, inclusive of transfers, and day passes for a family of four Disneyland Park Anaheim California – Value \$3000
- 5.1 Tickets are not transferable or redeemable for cash and the tickets are valid until 30 June 2005. All travel must be completed by this date;
- 5.2 Booking sheet needs to be submitted to Qantas by mail or facsimile at least 60 days prior to travel in order for the necessary flight arrangements to be made. Every effort will be made to comply with your requested flight times and dates, however this may not always be possible in the event of heavily booked flights. In these instances we will make every attempt to book the next best available for you;
- 5.3 Prize values are based upon the recommended retail prices at the time of printing (inclusive of GST). The promoter accepts no responsibility for change in prize value between the commencement date of the promotion and the ultimate travel date.
- 5.4 Prize winner tickets do not accrue Qantas Frequent Flyer redemption points. All applicable taxes and airport charges in respect of the winner tickets are the responsibility of the winner and traveling companions;
- 5.5 The winner is responsible for all other expenses including any applicable costs relating to passports, visas, airport taxes and government levies, all transfers (except where specified in itinerary), spending money, meals (except where specified), beverages (except where specified), all insurance, all other ancillary costs (such as telephone, laundry, and any other activities not stated). Travel insurance is not included in the prize and will be the responsibility of the winner. Travel insurance is highly recommended.
- 5.6 If the competition winner is under 18 years of age at the time of travel, in order to participate in the prize the major prize winner must be accompanied at all times by a parent or legal guardian over the age of 18 years old.

6. The secondary prize consists of

- An opportunity for four children aged between 4 and 8 years old to be a part of Hi-5's studio audience.

6.1 All children must be between the ages of 4 and 8 years old at the time of attending the studio recording.

6.2 The prize has no monetary value, is not redeemable for cash and must be taken on one of the following dates 19th October 2004, 20th October 2004, 7 December 2004 or 8 December 2004.

6.3 The prize winner and their companions are entitled to attend on only one of the four days as outlined in section 6.2.

6.4 The producers of Hi-5 reserve the right to change the above dates as dictated to by their production needs. In the unlikely event that the winner has booked attendance at a recording session that is cancelled and or rescheduled, the producers of Hi-5 will contact the winner to advise them of the change. If the winner and their companions are unable to attend the rescheduled recording session, the producers will, subject to the dictates of Hi-5s production needs and bookings, endeavour to accommodate them on another date, however, no absolute guarantee is given and no compensation monetary or otherwise is offered.

6.5 All four children must attend as a group on the same recording date.

6.6 Winners will be given instructions as to how to contact Hi-5s production office to redeem their prize and the recording session to be attended must be booked no later than 15 October 2004.

6.7 Participation in the Hi-5 studio audience will be subject to Hi-5s standard terms and conditions for audience participation. These terms and conditions are available from the Hi-5 production office.

6.8 The final decision as to a child's eligibility to attend the recording session remains with Hi-5

7. All people in Australia who pre-purchase by phone or over the internet a Kids Universe 2004 One Day Entry Pass prior to September 23rd 2004 will automatically qualify to win the prize packs, except where indicated under sections 4,5 & 6 above.
